## NEWS

- The meeting of the AS FH CU **on 8 February** was a constituent meeting and a new board was elected. J. Wohlmuth Markupová was again elected as the President of the Senate. T. Chavalková Badurová was re-elected Vice-President for the student chamber. J. Tuček was elected as the new Vice-President for the Academic Staff Chamber.  
Furthermore, approval was given for the appointment of new members of the Disciplinary Board of FH CU, the Senate also approved the Plan of Implementation of the Strategic Plan of the Faculty of Humanities of Charles University for 2024 and discussed the draft text of the Dean's measures on the framework principles of career development, support and evaluation of academic and scientific staff and lecturers at the Faculty of Humanities of Charles University.
