The aforementioned prices for accommodation in the dormitory are valid for one bed and one bed day, including VAT in the current rate.

These prices are exclusive of the city tax, which is added to the price of accommodation for stays shorter than 60 days according to the currently valid ordinances of the individual city districts.

The aforementioned prices for accommodation in the family dormitory are valid for one bed and one bed day, including VAT in the current rate.

The prices don't include the following services: electric power, water and sewerage costs.

The client agrees to pay for these services in advance payments. The amounts will be defined in the Calculation sheet, attached to the Accommodation contract for the family dormitory. The advance payments for the consumption of electric power, water and sewerage costs will be cleared on the last day of the calendar year, based on actual measurement and valid prices of energy and services. Other services are included in the accommodation price.

If the client with his/her child uses the whole quadruple bedroom, the overall price is the listed price for a single bed, multiplied by four.

Section 3 Value added tax (VAT)

The prices include VAT according to the current rate. However, they don't include local accommodation tax, which may or may not be set according to the valid legislation.

Section 4 Discounts from standard accommodation prices

1. In case of optimization of the dormitory capacity, discounts from standard accommodation prices are applicable in the following way, pursuant to the General terms and conditions of accommodation:
 - a) If the client, on the provider's request, moves from the current room to the new one within the same dormitory, he/she is entitled for the one-off discount of Czk 700.
 - b) If the client moves for the second time, he/she is also entitled for the one-off discount of Czk 700.
 - c) If the client moves due to reconstruction, he/she is also entitled for the one-off discount of Czk 700.

Section 5 Fees and penalties

The dormitories can charge the clients with these fees and penalties:

- a) Handling fee for the provider for cancelled booking: Czk 500,
- b) Penalty for late rent payment – Czk 250 for every started month in delay,
- c) Long-term deposit of Czk 2100, for the next academic year, upon the submission of the request for accommodation in the Charles University dormitories.

2. The subject of the local residence fee (hereinafter referred to as the "fee") is a paid stay of a maximum of 60 consecutive calendar days with an individual residence provider. The fee is payable by a person who is not registered in the municipality and who is provided with accommodation lasting no more than 60 consecutive calendar days with a single accommodation provider. The basis of the fee is calculated on a per day basis, excluding the first day of the stay. The number of overnight stays in the municipality with the accommodation provider is thus decisive.

- a.) Hradec Králové 40,- CZK
- b.) Pilsen 25,- CZK.

Section 6 Approval clause

The Board of Dormitories and Refectories approved to the standard accommodation prices on 6th December 2023.

Section 7 Final provisions

1. This provision is valid on the day of issue, and effective as of 1.3.204.
2. This provision cancels the Director's provision 6/2023 as of 17.3.2023.
