# Amendment of the Dean's Directive No. 11/2020: Schedule of the 2020/2021 academic year

# **Article 1: Introductory provisions**

In accordance with the Rector's Directive of Charles University No. 51/2020, this Dean's Directive No. 1/2021 amends and supplements the Dean's Directive No. 11/2020 of 3 July 2020.

# Article 2: Specific changes and additions to the Dean's Directive No. 11/2020

1. In Article 2, the date of the examination period in the summer term is amended as follows:

"Exam period in the summer term:	24. 5. – 31. 7. 2021
	1. 9. – 17. 9. 2021"

2. In Article 2, the date of the summer holidays is amended as follows: *"Summer holiday: 1. 8. – 31. 8. 2021"* 

- 3. In Article 2, the date of the open day for those interested in doctoral studies is added as follows: "17. 2. 2021 (Wednesday) - for those interested in doctoral studies"
- 4. Article 2 amends the third deadline for the submission of the bachelor's thesis and the binding application for the Defense of the bachelor's thesis and the Examination in Humanities in the bachelor's study in Czech and English as follows:

"Deadline for submission to 30. 7. 2021"

5. In Article 2, the following is added to the third deadline for submission of the diploma thesis and the binding application for the state examination:

"(the deadline for individual study programs may be extended by a decision of their guarantors until 23 July 2021)"
