## **Third amendment to the Dean's Directive No. 11/2020: Schedule of the academic year 2020/2021**

### **Article 1: Subject of the Directive**

This Dean's Directive No. 7/2021 amends and supplements the Dean's Directive No. 11/2020 as amended by the Dean's Directive No. 1/2021 of 12 January 2021 and No. 6/2021 of 6 April 2021.

### **Article 2: Specific changes and additions to the Dean's Directive No. 11/2020**

1. In Article 2, the following information regarding the possibility of tuition in the Exam Period of the Summer Term, which reads as follows: "Exam Period in the Summer Term (the teacher may, in agreement with the guarantor of the study programme, decide to use part of the Exam Period for tuition purpose)".
2. In Article 2, the period for the enrolment in the second or higher year of Bachelor's and Master's studies changes: "1 July - 24 September 2021".

### **Article 3: Final Provisions**

1. This Directive shall come into force on the day on which it is signed.
2. This Directive shall take effect on 17 May 2021.

The thesis must be submitted at least half a year before its planned defense.</p>
